**ORDER:**

**WHEREAS**, the term of office of the elected committee of management (*for brevity "the committee"*) of the Puducherry Govt. Group B and C Staff Co-operative Credit Society Ltd., No.P.691 (*for brevity "the society"*) expired on **31.3.2024**;

**2) AND WHEREAS**, based on the request letter dated 27.05.2024 of the committee, the term was extended for a period of three months commencing from 01.04.2024, *vide reference 2<sup>nd</sup> cited*;

**3) AND WHEREAS**, the President of the said society vide reference cited stated that it is unable to conduct election to the committee of management for the period from **1.7.2024 to 31.3.2027** due to existence of Model Code of Conduct for Lok Sabha Elections, 2024;

**4) AND WHEREAS**, the President sought for further extension of the committee for a period of three months commencing from 01.07.2024;

**5)** In view of the above, the Registrar of Co-operative Societies is satisfied that, as requested by the committee, the term of office of the existing committee has to be extended further for a period of three months;

**6) NOW, THEREFORE**, in exercise of the powers conferred under **clause (b) of sub-section (5) of Section 32** of the Puducherry Cooperative Societies Act, 1972, read with **sub-rule (2) of Rule 41** of the Puducherry Cooperative Societies Rules, 1973, **the Registrar of Co-operative Societies hereby further extends the term of office of the existing committee of management** of the Puducherry Govt. Group B and C Staff Co-operative Credit Society Ltd., No.P.691 **for a period of three months commencing from 01.07.2024**;

7) The committee of management is directed to arrange to conduct election to the new Committee of Management, before the expiry of their extended term.
