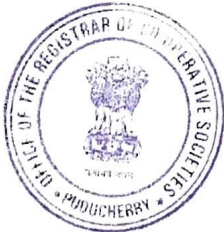
ORDER:

In pursuance to the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Co-operative Societies Rules, 1973, the Registrar of Co-operative Societies hereby permits the Oulgaret Municipality Staff Cooperative Credit Society Ltd. No.P.454 to incur an expenditure of not exceeding **Rs.2,96,000/- (Rupees two lakhs ninety six thousand only)**, from the general funds of the society, towards issue of **gift coupons to 296 members** of the society, worth **Rs.1,000/- (Rupees one thousand only)** each, which enables them to make purchase only from the following cooperative institutions:

- a) Pondicherry Co-operative Wholesale Stores Ltd., No.P.44 (**Amudhasurabi**)
- b) Puducherry State Weavers Cooperative Society Ltd., No.P.57 (**PONTEX**)
- c) Pondicherry Co-operative Handloom Export Development Project Ltd., (**PONFAB**)
- d) Pondicherry Co-operative Building Centre Ltd., No.P.554
- e) Pondicherry Central Co-operative Processing, Supply & Marketing Society Ltd., No.P.31.
- f) Pondicherry Co-operative Milk Producers' Union No. P. 1 (**PONLAIT**)
- g) Pondicherry State Co-operative consumers Federation No. P.429 (**CONFED**)

2. The actual expenditure shall be charged in the accounting year **2024-25** itself and proper account shall be maintained for the issue of gift coupons.
