ORDER:

WHEREAS, the term of office of the existing Committee of Management of the Kariyamanickam Co-operative Milk Producers' Society Ltd., No.P.275, expired on 30.06.2023;

AND WHEREAS, on request of the existing committee of management, the term of the existing committee was extended on two spells up to 31.12.2023 vide proceedings 1st and 2nd cited with instructions to complete the election before the extended period;

AND WHEREAS, the committee of management failed to conduct the Election to form New Committee of Management within the stipulated period;

AND WHEREAS, in view of the impasse situation, the undersigned is of the opinion that an Administrator has to be appointed to manage the affairs of the society;

AND WHEREAS, the undersigned is also satisfied that it is not reasonably practicable to publish a notification in the notice board of the society, inviting objections for the proposed appointment of an Administrator for the society as provided under first proviso to sub-section (1) of Section 33 of the said Act, as an alternative arrangement is to be made immediately;

NOW THEREFORE, in view of the above and in exercise of the powers conferred on me under sub-section (1) of Section 33 of Puducherry Co-operative Societies Act, 1972, the undersigned is hereby appoints Thiru.A.Rajamohan Senior Inspector (Handloom Section), Co-operative Department Puducherry as the Administrator of the Kariyamanickam Co-operative Milk Producers' Society Ltd. No.P.275, with effect from 01.01.2024 in addition to his normal duties;

The Administrator shall, subject to the control of the Registrar of Co-operative Societies and to such directions as he may give from time to time under sub section (2) of Section 33 of the Act, and have power to exercise all or any of the functions of the committee or any officer of the society and take all such actions as may be required in the interest of the society.
