ORDER:

WHEREAS, the term of office of the existing committee of management of the Nedungadu Farmers Service Co-operative Society Ltd., No. P. 72 expired on 30.03.2021.

2. AND WHEREAS, on request of the committee of management, the term of the existing committee was extended upto 30.09.2021 vide proceedings 1st cited with instructions to complete the election before the extended period;

3. AND WHEREAS, the committee of management of the society has not taken any steps for conduct of election to elect the new committee of management before expiry of its extended term due to spread of COVID-19 situation;

4. AND WHEREAS, I am satisfied that a new committee cannot be constituted before the expiry of the extended term of office of the existing committee;

5. AND WHEREAS, in view of the above, I am satisfied to appoint an Administrator under sub-section (1) of the section 33 of the Puducherry Co-op. Societies Act, 1972 to manage the affairs of the said society till a new committee enters upon office;

6. AND WHEREAS, I am also satisfied that it is not practicable to publish a notice on the notice board of the society inviting objections to the proposal of appointment of an Administrator to the said society as required under the first proviso to sub-section (1) of the section 33, as alternative arrangements is to be made expeditiously;

7. AND WHEREAS, the financing bank, viz. Pondicherry State Co-operative Bank Ltd., has been consulted in this regard and the said institution has no objection for appointing an Administrator to the said society;

8. NOW THEREFORE, in view of the above and in exercise of the powers conferred on me under sub-section (1) of the section 33 of the Puducherry Co-operative Societies Act, 1972 I hereby appoint Thiru. V. Ramaiyan, Co-operative Officer, Karaikal as the Administrator of the Nedungadu Farmers Service Co-operative Society Ltd., No. P. 72 with effect from 01.10.2021.

9. The Administrator shall exercise all the functions of the said committee subject to my control and such directions as I may give from time to time under sub-section (2) of the said section and take all such action as may be required in the interest of the said society.
