In pursuance of the reference cited and in exercise of the powers conferred on me under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, I permit the Karaikal Electricity Employees' Cooperative Credit Society Ltd., No.P.766 to incur an expenditure of Rs.2,61,431/- (Rupees two lakh sixty-one thousand four hundred and thirty one only), from out of the general funds of the said society, towards the disbursement of interest rebate to 67 members of the said society for the year 2020-2021, i.e., 12% on the interest collected of Rs.21,78,593/, through Electronic Clearing Service (ECS).
