ORDER:

In pursuance of the reference cited and in exercise of the powers conferred on me under Rule 58 of the Puducherry Co-operative Societies Rules, 1973, I permit the PAJANCOA Staff Cooperative Credit Society Ltd., No. P. 669 to incur an expenditure not exceeding **Rs. 7,59,483/-** (Rupees seven lakh fifty-nine thousand four-hundred and eighty three only), from out of general funds of the society, towards the disbursement of interest rebate to **123 members** of the society for the year **2020-2021**, i.e., 18.06% on the interest collected of Rs.42,05,359/-, **through Electronic Clearing Service (ECS)**. The actual expenditure shall be charged in the accounting year 2020-2021 itself and proper account shall be maintained for the disbursement of interest rebate.
