ORDER:

In pursuance of the reference cited and in exercise of the powers conferred on me under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, I permit the Pondicherry Power Corporation Employees' Cooperative Credit Society Ltd., No.P.759 to incur an expenditure of **Rs. 1,47,973/-** (Rupees one lakh forty-seven thousand nine hundred and seventy-three only), from out of the general funds of the said society, towards the disbursement of **interest rebate to 51 members of the said society for the year 2020-2021**, i.e., thirteen per cent (13%) on the interest collected of Rs.11,38,255/, **through Electronic Clearing Service (ECS)**. The actual expenditure shall be charged in the accounting year 2020-2021 itself and proper account shall be maintained for the disbursement of interest rebate.
