2. Thiru. D. Prabakaran, M.No.645 shall act as the President of the said committee. The Committee shall have power to exercise all or any of the functions of the committee subject to my control and to such directions as I may give from time to time under sub-section (2) of the said section and take all such action as may be required in the interest of the said society.

3. The Committee shall take expeditious steps to hold election.

4. The three members committee should not take any policy decision, which may affect the financial position of the society, without prior permission of the Registrar of Co-operative Societies.

5. The three members committee should not engage or remove any staff, without prior permission of the Registrar of Co-operative Societies.
6. The three members committee should not either reinstates the staffs, who are under suspension, or place anyone under suspension, without prior permission of the Registrar of Co-operative Societies.
7. The three members committee should invariably adhere the above said instructions, without any lapse. It may be noted that violation of the above said instructions, if any will be liable for legal action in accordance with law.
