ORDER:

In partial modification of proceedings read above and in exercise of the powers conferred under section 33 (1) of the Puducherry Co-operative Societies Act, 1972, the undersigned hereby appoint a Committee consisting of the following three members to manage the affairs of Ariyankuppam Primary Agricultural Co-operative Credit Society Ltd. P.22 for a period of six months from the date of their assuming charges, vice Thiru. V. Shanmougam, Administrator of the Society with immediate effect.

(i)	Thiru.R. Kamaraj	M. No. 1215	President
(ii)	Thiru A. Meiazhagan,	M.No.1238	Director
(iii)	Thiru.K. Sankar,	M. No.727	Director

2. Thiru.R. Kamaraj, M.No. 1215 shall act as the President of the said committee. The Committee shall have power to exercise all or any of the functions of the committee subject to my control and to such directions as may give from time to time by the undersigned under sub-section (2) of the said section and take all such action as may be required in the interest of the said society.

3. The Committee shall take expeditious steps to hold election.

4. The three members committee should not take any policy decision, which may affect the financial position of the society, without prior permission of the Registrar of Co-operative Societies.

5. The three members committee should not engage or remove any staff, without prior permission of the Registrar of Co-operative Societies.

6. The three members committee should not either reinstate the staff, who is under suspension, or place any one under suspension, without prior permission of the Registrar of Co-operative Societies.
