ORDER:

WHEREAS, the term of office of the committee of management of the Rajaji Weavers Co-operative Society Ltd., No. P- 2 expired on 30.06.2023;

AND WHEREAS, the Committee of Management has not taken any steps for conduct of election before its expiry of term viz., 30.06.2023;

AND WHEREAS, I am satisfied that a new committee cannot be constituted before the expiry to the term of office of the existing committee of management of the said society;

AND WHEREAS, in view of the above, I am of the opinion that a three member committee is to be appointed under Section 33 of the Puducherry Co-operative Societies Act, 1972 to manage the affairs of the said society till a new committee enters upon office;

AND WHEREAS, I am also satisfied that, it is not reasonably practicable to publish a notice, inviting objections for the proposed appointment of three member committee for the society as provided under proviso sub section (1) of section 33 of the Puducherry Co-operative Societies Act, 1972, as an alternative arrangement is to be made immediately;

NOW, THEREFORE, in view of the above and in exercise of the powers conferred on me under sub section (1) (b) (i) of section 33 of the Puducherry Co-operative Societies Act, 1972, I hereby appoint a committee consisting of the following three members to manage the affairs of the Rajaji Weavers Co-operative Society Ltd., No. P- 2 with effect from 01.07.2023;

- (i) Tmt. V.Amudha, M.No.1723
- (ii) Thiru. N. Kalimuthu, M.No.602
- (iii) Tmt . R. Meenatchi, M.No.1692

Tmt. V.Amutha, M.No.1723 shall act as the President of the said committee. The Committee shall have power to exercise all or any of the functions of the committee subject to my control and to such directions as I may give from time to time under sub-section (2) of the said section and take all such action as may be required in the interest of the said society.

The Committee shall take expeditious steps to hold election.
