Read: 1. Letter dated 13.06.2024 received from the President of the Puducherry Vector Control Research Centre Staff Cooperative Credit & Thrift Society Ltd., No.P.402 along with copy of Resolution No.1 dated 07.06.2024 of the committee of management.

ORDER:

WHEREAS, the term of office of the elected committee of management (*for brevity “the committee”*) of the Puducherry Vector Control Research Centre Staff Cooperative Credit & Thrift Society Ltd., No.P.402 (*for brevity “the society”*) expired on **31.3.2024**;

2) AND WHEREAS, based on the request letter dated 06.03.2024 of the committee, the term was extended for a period of three months commencing from 01.04.2024, *vide reference 2nd cited*;

3) AND WHEREAS, the President of the said society *vide reference 1st cited* stated that it is unable to conduct election to the committee of management for the period from **1.7.2024 to 31.3.2027** as per Section 32 (5) (a) of the Puducherry Cooperative Societies Act, 1972 due to existence of Model Code of Conduct for Lok Sabha Elections, 2024 till 6th June 2024;

4) AND WHEREAS, the President sought for further extension of the committee for a period of three months commencing from 01.07.2024;

5) In view of the above, the Registrar of Co-operative Societies satisfied that, as requested by the committee, the term of office of the existing committee is to be further extended for a period of three months;

6) **NOW, THEREFORE**, in exercise of the powers conferred under **clause (b) of sub-section (5) of Section 32** of the Puducherry Cooperative Societies Act, 1972, read with **sub-rule (2) of Rule 41** of the Puducherry Cooperative Societies Rules, 1973, **the Registrar of Co-operative Societies hereby further extends the term of office of the existing committee of management of the Puducherry Vector Control Research Centre Staff Cooperative Credit & Thrift Society Ltd., No.P.402 for a period of three months commencing from 01.07.2024;**

7) The committee of management is directed to arrange to conduct election to the new Committee of Management, before the expiry of their extended term i.e., before 30.09.2024.
