In pursuance to the reference cited and in exercise of the powers conferred on me under sub-section (3) of section 11 of the Puducherry Co-operative Societies Act, 1972, read with Rule 7 of the Puducherry Co-operative Societies Rules, 1973, I am pleased to register the amendment to bye-law No.12 (i) of the bye-laws of **the UCO Bank Employees Cooperative Thrift & Credit Society Ltd., No.P.148**, vide resolution cited and as detailed hereunder. The said amendment shall come into force from the date of issue of this proceedings.

12(i)	Authorised Share Capital: The authorised share capital of the society shall be Rs.25,00,000/- (Rupees twenty five lakhs only) made up of 24,750 "A" class share of Rs. 100/- (Rupees one hundred only) each and 2,500 "B" class shares of Rs.10/- (Rupees ten only) each.	Authorised Share Capital: The authorised share capital of the society shall be Rs.50,00,000/- (Rupees fifty lakhs only) made up of 49,500 "A" class share of Rs. 100/- (Rupees one hundred only) each and 5,000 "B" class shares of Rs.10/- (Rupees ten only) each.

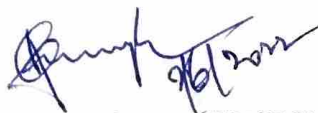
