PROCEEDINGS OF THE REGISTRAR OF COOPERATIVE SOCIETIES, PUDUCHERRY
(Issued under Section 32 of the Puducherry Cooperative Societies Act, 1972)

Sub: Consumers – The Pondicherry Toy Makers Service Industrial Cooperative Society Ltd., No.P.427 - Committee of management – Extension of term under Section 32 of the Puducherry Cooperative Societies Act, 1972 – Order - Issued.

Read: (1) Letter dated 25.08.2021 received from the Pondicherry Toy Makers Service Industrial Cooperative Society Ltd., No.P.427, along with a copy of Resolution No.1 dated 25.08.2021 of the committee of management.

(2) RCS Proceedings even No. and dated 22.07.2021.

ORDER:

WHEREAS, the extended term of office of the elected committee of management (for brevity “the committee”) vide reference 2nd cited, of the Pondicherry Toy Makers Service Industrial Cooperative Society Ltd., No.P.427 (for brevity “the society”) expires on 30.09.2021;

2) AND WHEREAS, the committee of the above said society has requested, vide references 1st cited, to extend the term for a further period of three (3) months citing the yearly conduct of the Kolu Exhibition;

3) AND WHEREAS, in view of the above, I am satisfied that, the term of office of the committee of the Pondicherry Toy Makers Service Industrial Cooperative Society Ltd., No.P.427 is to be extended for further period of three months in as much as under the provisions of the Puducherry Cooperative Societies Act, 1972 and the Rules made thereunder, maximum period of extension of term of office of the committee of management of societies shall not exceed six (6) months in aggregate and three (3) months at any one time.

4) NOW, THEREFORE, on the above reason of the yearly conduct of the Kolu Exhibition and in exercise of the powers conferred on me under clause (b) of sub-section (5) of Section 32 of the Puducherry Cooperative Societies Act, 1972, read with sub-rule (2) of Rule 41 of the Puducherry Cooperative Societies Rules, 1973, I further extend the term of office of the existing elected committee of the Pondicherry Toy Makers Service Industrial Cooperative Society Ltd., No.P.427 for a further period of three (3) months commencing from 01.10.2021 to 31.12.2021.

5) The committee of management of the said society is directed to arrange to conduct the elections, before the expiry of the extended term, to install a new committee with effect from 01.01.2022.

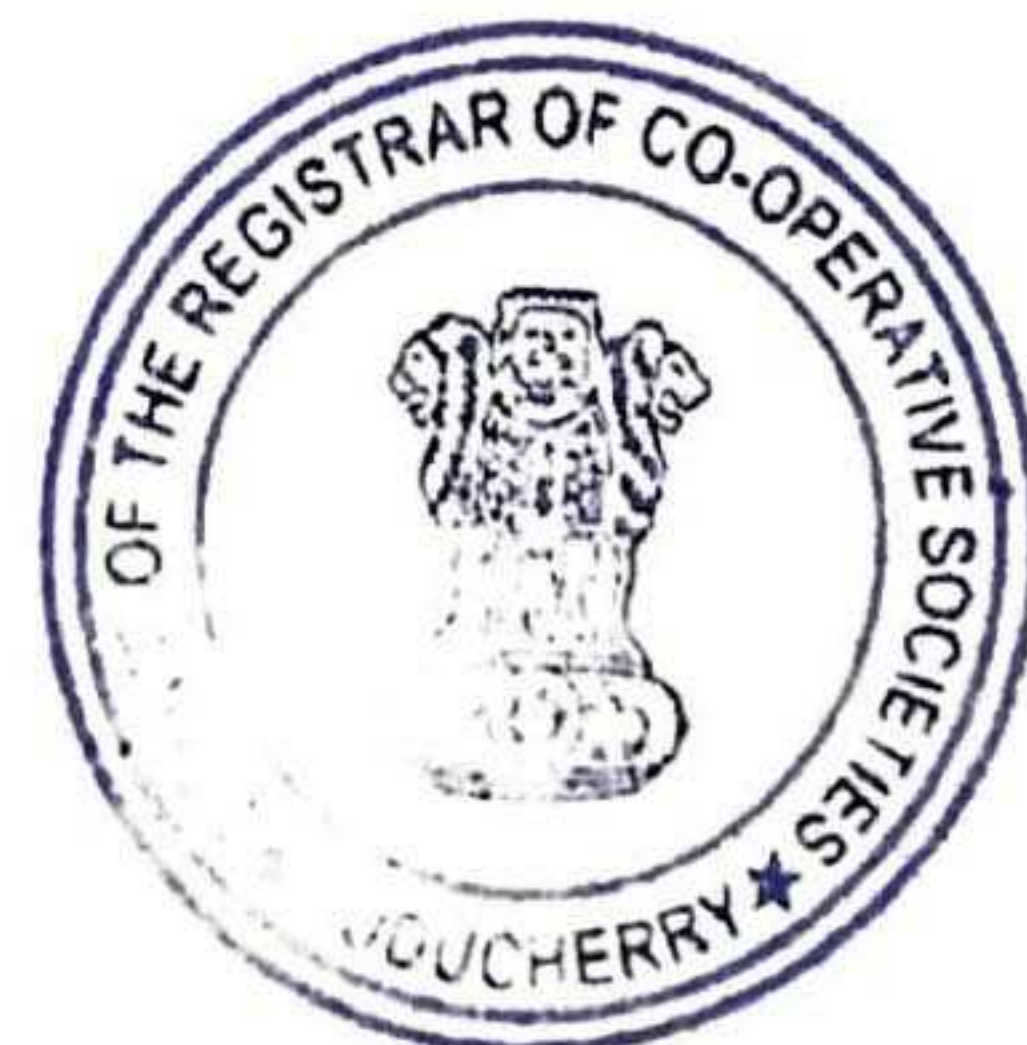
