Sub: The Mother Theresa Anganwadi Employees Cooperative Credit Society Ltd., No.P.804 - Committee of Management –Extension of term under Section 32 of the Puducherry Cooperative Societies Act, 1972 – Order - Issued.

Read:1. Letter dated 14.06.2023 received from the President of the Mother Theresa Anganwadi Employees Cooperative Credit Society Ltd., No.P.804, along with copy of Resolution No.1 dated 08.06.2023 of the committee of management.
2. RCS Proceedings No.RCS/Planning/Emp.Cr./No.P.804/2022/120 dated 23.03.2023.

ORDER:

WHEREAS, the term of office of the elected committee of management (*for brevity "the committee"*) of the Mother Theresa Anganwadi Employees Cooperative Credit Society Ltd., No.P.804 (*for brevity "the society"*) expired on 31.3.2023;

2) AND WHEREAS, based on the request letter dated 06.03.2023 of the committee, the term was extended for a period of three months commencing from 01.04.2023, *vide reference 2nd cited*;

3) AND WHEREAS, the President of the society requested for further extension of the existing term for three months from 01.07.2023 to 30.09.2023, as it is impossible to conduct election due to the following reasons;

The present number of members in the society is 674. As the number of members are more than 500, the total members are to be divided as suitable constituencies as per Rule 31(1) of the PCS Rules, 1973. The society proposed to conduct the general body meeting of the society on 1.7.2023 for carrying out the amendment in Bye-law No. 32(1) of the bye-laws of the society for division of constituencies and conduct election;

4) In view of the above, I am satisfied that, as requested by the committee, the term of office of the existing committee is to be further extended for a period of three months;

5) **NOW, THEREFORE**, in exercise of the powers conferred on me under clause (b) of sub-section (5) of Section 32 of the Puducherry Cooperative Societies Act, 1972, read with sub-rule (2) of Rule 41 of the Puducherry Cooperative Societies Rules, 1973,
