Sub: Five primary co-operatives in the consumer sector at Karaikal region – Non-functioning and remains dormant – Winding up – **Appointment of Liquidator** under Section 127 of the Puducherry Co-operative Societies Act, 1972 – **Order – Issued.**

Read: Proceedings No.5/8/1/3/RCS/CONS/MISC/2020/205, dated 25.08.2021 the Registrar of Cooperative Societies, Puducherry.

ORDER:-

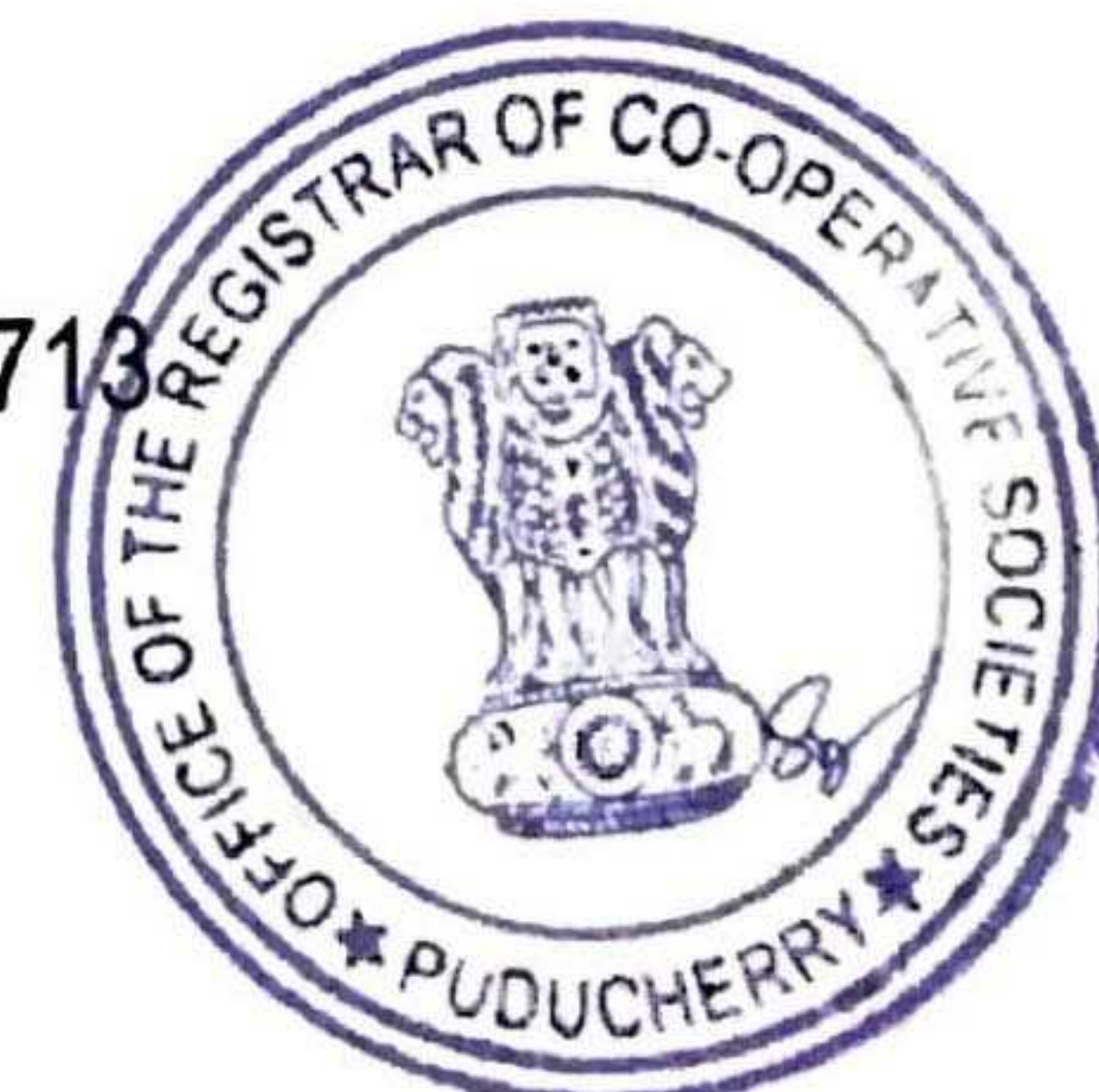
WHEREAS, an order was made, ***vide reference cited***, directing the winding up of the affairs of following five (5) primary co-operatives in the consumer sector at Karaikal region (***for brevity “the societies”***),

2) AND WHEREAS, consequent to the winding up of the society, a Liquidator is to be appointed, under sub-section (1) of Section 127 of the Puducherry Cooperative Societies Act, 1972 (***for brevity “the Act”***);

3) AND WHEREAS, the financing bank, viz., Pondicherry State Cooperative Bank Ltd., was consulted in respect of the proposal of appointing a Liquidator for the below societies and the said Bank consented for the said proposal.

4) NOW, THEREFORE, in exercise of the powers conferred on me under sub-section (1) of Section 127 of the Puducherry Cooperative Societies Act, 1972, read with clause (a) of Rule 66 of the Puducherry Cooperative Societies Rules, 1973, I hereby appoint **Thiru.P. Savarirajalu**, Senior Inspector, Karaikal as the Liquidator of the following five primary cooperative societies in the consumer sector at Karaikal region:

1. Kovilpathu Students Co-operative Stores Ltd., No.P.412
2. Karaikal Women Co-operative Tailoring Society Ltd., No.P.566
3. Dr. Ambedkar Schedule Caste Educated Unemployed Youth Co-operative Society Ltd., No.P.658
4. Karaikal Transport Co-operative Society Ltd., No.P.692
5. Karaikal Pugazh Handicrafts Artisans Co-operative Society Ltd., No.P.713



5) The President / Administrator of the societies are directed to handover the charges of their societies concerned to the said Liquidator. Charges of the societies handed over and taken over shall be informed to this office.

6) On taking over of charges of the societies, the said Liquidator shall arrange to discharge the liabilities of the societies subject to availability of funds from the realizable assets of the societies at the earliest possible. On completion of the liquidation process, the said Liquidator shall submit report to the undersigned to make an order for the cancellation of registration of the societies under Section 129 of the said Act.
