ORDER:

WHEREAS, the term of office of the existing committee of management of the Koonichempet Primary Agricultural Co-operative Credit Society Ltd., No.P.82 expires on 31.12.2023;

2. AND WHEREAS, the President of the said society has requested in his letter vide 2nd cited to appoint an Election Officer to conduct election to elect a new committee. After verification of the Minutes book, it is found that the election scheduled has not been approved by the committee of management. Hence, the election schedule is found to be invalid.

3. AND WHEREAS, I am satisfied that a new committee cannot be constituted before the expiry of the term of office of the existing committee i.e. on 31.12.2023;

4. AND WHEREAS, in view of the above, I am satisfied to appoint an Administrator under sub-section (1) of the section 33 of the Puducherry Co-op. Societies Act, 1972 to manage the affairs of the said society till a new committee enters upon office.

5. AND WHEREAS, I am also satisfied that it is not practicable to publish a notice on the notice board of the society inviting objections to the proposal of appointment of an Administrator to the said society as required under the first proviso to sub-section (1) of the section 33, as alternative arrangements is to be made expeditiously;

6. AND WHEREAS, the financing bank viz. Pondicherry State Co-operative Bank., has been consulted in this regard and the said institution has no objection for appointing an Administrator to the said society;

7. NOW THEREFORE, in view of the above and in exercise of the powers conferred on me under sub-section (1) of the section 33 of the Puducherry Co-operative Societies Act, 1972 I hereby appoint Thiru. K. Dhanabalan, Co-operative Officer, as the Administrator of the Koonichempet Primary Agricultural Co-operative Credit Society Ltd., No.P.82 with effect from 01.01.2024.

8. The Administrator shall exercise all the functions of the said committee subject to my control and such directions as I may give from time to time under sub-section (2) of the said section and take all such action as may be required in the interest of the said society.
