ORDER:

WHEREAS, the term of office of the existing committee of management of the Kombakkam Primary Agricultural Co-operative Credit Society Ltd., No.P.746 expires on 31.12.2023

2. AND WHEREAS, the committee of management of the said society has requested the Registrar of Co-operative Societies vide letter cited to extend its term of office for a period of six months from 1.1.2024 to 30.6.2024 stating the reason that they could not conduct election to elect a new committee before 31.12.2023 in view of the tense situation prevailing in the village due to the misappropriation of funds/ jewels case pending at the Court and hence it needs time to get back the jewels from the court;

3. AND WHEREAS, the request of the said committee of management is not considered since the misappropriation of funds / Jewels happened during the tenure of this present committee of management and moreover the said committee has failed to take action to conduct election to the committee of management of the society;

4. AND WHEREAS, I am satisfied that a new committee cannot be constituted before the expiry of the term of office of the existing committee;

5. AND WHEREAS, in view of the above, I am further satisfied to appoint an Administrator under sub-section (1) of the section 33 of the Puducherry Co-op. Societies Act, 1972 to manage the affairs of the said society till a new committee enters upon office.

6. AND WHEREAS, I am also satisfied that it is not practicable to publish a notice on the notice board of the society inviting objections to the proposal of appointment of an Administrator to the said society as required under the first proviso to sub-section (1) of the section 33, as alternative arrangements is to be made expeditiously;

7. AND WHEREAS, the financing bank viz. Pondicherry State Co-operative Bank., has been consulted in this regard and the said bank has no objection for appointing an Administrator to the said society;

8. NOW THEREFORE, in view of the above and in exercise of the powers conferred on me under sub-section (1) of the section 33 of the Puducherry Co-operative Societies Act, 1972 I hereby appoint Thiru. N.R.Sankar, Senior Inspector (Audit Section) as the Administrator of the Kombakkam Primary Agricultural Co-operative Credit Society Ltd.,No.P.746 with effect from 1.1.2024.

9. The Administrator shall exercise all the functions of the said committee subject to my control and such directions as I may give from time to time under sub-section (2) of the said section and take all such action as may be required in the interest of the said society.
