ORDER:

WHEREAS, the term of office of the committee of management of the P.S Palayam Primary Agricultural Co-operative Credit Society Ltd., No. P.123 expires on 31.12.2023;

2. AND WHEREAS, the committee of management has not taken any steps for conduct of election before expiry of its term viz., 31.12.2023;

3. AND WHEREAS, I am satisfied that a new committee cannot be constituted before the expiry to the term of office of the existing committee of management of the said society;

4. AND WHEREAS, in view of the above, I am satisfied to appoint a three member committee under Section 33 of the Puducherry Co-operative Societies Act, 1972 to manage the affairs of the said society till a new committee enters upon office;

5. AND WHEREAS, I am also satisfied that, it is not reasonably practicable to publish a notice on the notice board of the society, inviting objections to the proposal of appointment of three member committee to the said society as required under the first proviso to sub section (1) of section 33 of the Puducherry Co-operative Societies Act, 1972, as an alternative arrangement is to be made immediately;

6. AND WHEREAS, the financing bank viz., the Pondicherry State Co-operative Bank has been consulted in this matter of appointment of a three member committee and the said Bank has no objection to the said proposal;

7. NOW, THEREFORE, in view of the above and in exercise of the powers conferred on me under sub section (1) of section 33 of the Puducherry Co-operative Societies Act, 1972, I hereby appoint a committee consisting of the following three members to manage the affairs of the P.S Palayam Primary Agricultural Co-operative Credit Society Ltd., No. P.123 with effect from 1.1.2024;

8. Thiru. K.D Prabakaran, M.No.645 shall act as the President of the said committee. The Committee shall have power to exercise all or any of the functions of the committee subject to my control and to such directions as I may give from time to time under sub-section (2) of the said section and take all such action as may be required in the interest of the said society.

9. The Committee shall take expeditious steps to hold election.

10. The three members committee should not take any policy decision, which may affect the financial position of the society, without prior permission of the Registrar of Co-operative Societies.

11. The three members committee should not engage or remove any staff, without prior permission of the Registrar of Co-operative Societies.

12. The three members committee should not either reinstates the staffs, who are under suspension, or place any one under suspension, without prior permission of the Registrar of Co-operative Societies.
