Group B and C Staff Co-operative Credit Society Ltd., No.P.691** as detailed hereunder. The said amendment shall come into force from the date of issue of this proceedings.

Bye-law No.	Existing	Amended
12(1)	Authorised Share Capital: The authorised share capital of the society shall be Rs.5,00,00,000/- (Rupees Five crores only) made up of 4,99,900 "A" class shares of Rs.100/- each and 1,000 "B" class shares of Rs.10/- each.	Authorised Share Capital: The authorised share capital of the society shall be Rs.8,00,00,000/- (Rupees Eight crores only) made up of 7,99,800 "A" class shares of Rs.100/- each and 2,000 "B" class shares of Rs.10/- each.
