PROCEEDINGS OF THE REGISTRAR OF CO-OPERATIVE SOCIETIES, PUDUCHERRY
(Issued under Section 33 of the Puducherry Coop. Societies Act, 1972)

Sub: The Pondicherry University Staff Co-operative Credit Society Ltd., No. P. 508 - Appointment of Administrator under Section 33 of the Puducherry Co-operative Societies Act, 1972 - Order - Issued.

Read: 1. Letter dated Nil (received on 18-07-2025) received from the President of the Pondicherry University Staff Co-operative Credit Society Ltd., No. P. 508

2. Representations dated 18-07-2025 from Thiru G. Jayamurthy and the newly elected committee members, and copy of letter dated 17-07-2025 from Thiru. A. Nagaraju addressed to the Superintendent of Police (PCR Cell)

ORDER:

WHEREAS, the term of the elected Committee of Management of the Pondicherry University Staff Co-operative Credit Society Ltd., No. P.508 expired on 18-07-2025;

2. AND WHEREAS, the outgoing committee conducted elections to form a new committee for the term from 19-07-2025 to 31-03-2028, and nine directors were elected on 14-07-2025;

3. AND WHEREAS, various representations received, as cited in reference 2, have brought to the notice of the undersigned that the office-bearer election held on 16-07-2025 was marred by procedural irregularities in the selection of President, Vice-President, and Treasurer, resulting in three different member combinations claiming the said posts;

4. AND WHEREAS, the Registrar is satisfied that the newly elected committee has failed to assume office on the date the term of the previous committee expired, i.e., 18-07-2025;

5. AND WHEREAS, in view of the above, the Registrar is of the opinion that it is necessary to appoint an Administrator under sub-section (1) of Section 33 of the Puducherry Co-operative Societies Act, 1972 to manage the affairs of the society until a new committee duly assumes office;

6. AND WHEREAS, it is further observed that inviting objections for the proposed appointment, as required under the first proviso to sub-section (1) of Section 33, is not practicable in the present circumstances where immediate alternative arrangements are necessary in the interest of the society;

7. AND WHEREAS, the financing bank viz., the Pondicherry State Co-operative Bank has been consulted and has conveyed it's no objection to the appointment of an Administrator;

8. NOW, THEREFORE, in exercise of the powers conferred under sub-section (1) of Section 33 of the Puducherry Co-operative Societies Act, 1972, the undersigned hereby appoints Thiru. A. Irusappan, Senior Inspector, Co-operative Department, Puducherry, as the Administrator of the Pondicherry University Staff Co-operative Credit Society Ltd., No. P.508, with effect from 19-07-2025, in addition to his normal duties.

9. The Administrator shall resolve all the issues represented to the Registrar of Co-operative Societies by various groups of members and thereafter a fresh election to the Committee of Management shall be conducted in an unbiased manner within six months from the date of assumption of charge.

10. He shall exercise all the powers and perform all the functions of the Committee, subject to the control and direction of the Registrar of Co-operative Societies, and take all necessary action in the interest of the said society as per sub-section (2) of Section 33.
