ORDER:

In pursuance of the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Cooperative Societies hereby permits the **Puducherry Govt. Group B & C Staff Coop. Credit Society Ltd., No.P.691** to utilize a sum of not exceeding **Rs.8,31,000/-** (Rupees Eight lakhs and thirty one thousand only), from out of the general funds of the said society, towards the issue of gift coupons to **831** members of the said society, worth **Rs.1,000/-** (Rupees one thousand only) each, which enables them to make purchases only from the below mentioned cooperative institutions, in conjunction with the IYC – 2025 and Cooperation among Co-operatives.
