am satisfied to appoint the said committee;

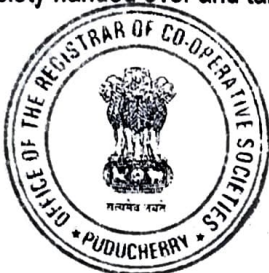
3) **NOW, THEREFORE**, in exercise of the powers conferred on me under Section 33 of the
