In pursuance to the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Co-operative Societies Rules, 1973, the Registrar of Co-operative Societies permits the Yanam P.W.D. Employees Co-operative Credit Society Ltd., No. P.675 to incur an expenditure not exceeding Rs. 3,34,293/- (Rupees three lakhs thirty-four thousand two hundred ninety three only), from the general funds of the said society towards disbursement of interest rebate to 38 & 41 members respectively of the said society for the year 2021-2022 & 2022-2023 respectively, as detailed below, through Electronic Clearing Service (ECS). The actual expenditure shall be charged in the accounting year 2021-2022 & 2022-2023 itself and proper account shall be maintained for the disbursement of interest rebate.

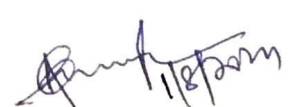
