In pursuance to the reference cited and in exercise of the powers conferred on me under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, I permit the **Puducherry Vector Control Research Centre Staff Cooperative Thrift & Credit Society Ltd., No.P.402** to incur an expenditure of not exceeding **Rs.3,45,487/-**-(Rupees three lakhs forty five thousand four hundred and eighty seven only), from the general funds of the said society, towards disbursement of interest rebate to **62** members of the said society for the year **2022-23**, **through Electronic Clearing Service (ECS)**, as **thirteen percent (13%) rebate** for the interest collected of **Rs.26,57,566/-** during the year 2022-23.
