ORDER:

In pursuance to the reference cited and in exercise of the powers conferred on me under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, I permit the Puducherry Cooperative Department Staff Cooperative Credit Society Ltd. No.P.80 to incur an expenditure not exceeding **Rs.2,24,000/-** (Rupees two lakhs twenty four thousand only), from the general funds of the society, towards issue of **gift coupon to 64 members** of the society, worth **Rs.3,500/-** (Rupees three thousand five hundred only) each, which enables them to make purchases only from the following cooperative institutions:

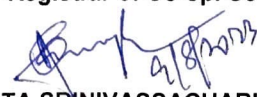
