<u>4. Limit of Loan (ST) Loan:</u> The maximum amount of loan that may be sanctioned to a member under these regulations shall not exceed Rs.2,00,000/- (Rupees Two lakhs only). Provided that no member shall be allowed to be indebted to the society for a sum exceeding Rs.25,00,000/-(Rupees Twenty five lakhs only) at any time <u>12. (1) RECOVERY OF LOAN</u> The loan shall be recovered in such of numbers of equal monthly installments, as the application may choose, along with interest due thereon, However, the installments shall not exceed twenty five (25);	<u>4. Limit of Loan (ST) Loan:</u> The maximum amount of loan that may be sanctioned to a member under these regulations shall not exceed Rs.3,00,000/- (Rupees Three lakhs only). Provided that no member shall be allowed to be indebted to the society for a sum not exceeding Rs. 30,00,000/-(Rupees Thirty lakhs only) at any time. <u>12. (1) RECOVERY OF LOAN</u> The loan shall be recovered in such of numbers of equal monthly installments, as the applicant may choose, along with interest due thereon, However, the installments shall not exceed thirty six (36);
