ORDER:

In pursuance to the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Co-operative Societies, hereby permits the Mahe Public Servants Cooperative Credit Society Ltd. No. P. 246 to incur an expenditure not exceeding **Rs.3,66,000/-** (Rupees three lakhs sixty six thousand only), from the general funds of the society, towards issue of **gift coupon to 732 members** of the society, worth **Rs. 500/-** (Rupees five hundred only) each on account of **ONAM FESTIVAL 2024** which enables them to make purchase only from the Mahe Consumer Cooperative Stores Ltd., Mahe.

The actual expenditure shall be charged in the accounting year 2023-24 itself and proper account shall be maintained for the issue of gift coupons.

This permission is accorded with the condition that the cooperative education fund upto the audit completed year 2020-21 should be remitted immediately into the Pondicherry State Cooperative Union and intimate the same to this office.
