ORDER:

In pursuance of the reference cited, and in exercise of the powers conferred under Rule 58 of the Puducherry Co-operative Societies Rules, 1973, the Registrar of Co-operative Societies hereby accords permission to the Puducherry Public Servants Co-operative Credit Society Ltd., No. P. 52, to incur an expenditure not exceeding Rs.50,00,000/- (Rupees fifty lakh only) from the general funds of the society, towards the issue of gift coupons to 5,000 members, each worth Rs. 1,000/- (Rupees one thousand only).

10. The Karaikal Central Cooperative Processing, Supply & Marketing Society Ltd., No.P.15.
