Sub: The Puducherry Public Servants Cooperative Credit Society Ltd., No.P.52 - Committee of Management –Extension of term under Section 32 of the Puducherry Cooperative Societies Act, 1972 – Order - Issued.

Read: 1. Letter No. PPSCCS/Estt./ 2022/642 dated 24.05.2022 received from the Secretary of the Puducherry Public Servants Cooperative Credit Society Ltd., No.P.52., along with copy of Resolution No. 10 dated 16.05.2022 of the committee of management.

ORDER:

WHEREAS, the term of office of the elected committee of management (*for brevity "the committee"*) of the Puducherry Public Servants Cooperative Credit Society Ltd., No.P.52 (*for brevity "the society"*) expired on 31.3.2022;

2) AND WHEREAS, based on the request letter dated 15.02.2022 of the committee, the term was extended for a period of three months commencing from 01.04.2022, *vide reference 2nd cited*;

3) AND WHEREAS, the Secretary of the society requested for further extension of the existing term for three months from 01.07.2022 to 30.09.2022, as it is impossible to conduct election due to the following reasons:

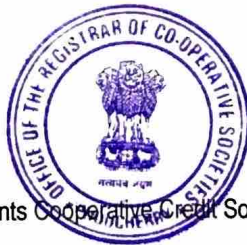
a) The society got building plan approval from the Puducherry Planning Authority and the existing board decided to build new building in their period of management and had given E-tender & supervision work to the Puducherry State Cooperative Housing Federation Limited for the construction of proposed new office building for the society at V.V.P Nagar, Thattanchavady.

b) The society is also preparing members voter list with photo image and the work will be completed by July 2022;

3) In view of the above, I am satisfied that, as requested by the committee, the term of office of the existing committee is to be extended for a period of three months.

4) **NOW, THEREFORE**, in exercise of the powers conferred on me under clause (b) of sub-section (5) of Section 32 of the Puducherry Cooperative Societies Act, 1972, read with sub-rule (2) of Rule 41 of the Puducherry Cooperative Societies Rules, 1973, **I extend the term of office of the existing committee of management** of the Puducherry Public Servants Cooperative Credit Society Ltd., No.P.52 **for a further period of three months commencing from 01.07.2022.**

5) **The committee of management is directed to arrange to conduct their election to the Committee of Management, before the expiry of their extended term and ensure that a new committee takes charges with effect from 01.10.2022.**
