ORDER

WHEREAS, the term of office of the existing committee of management of the Puducherry State Government Driver's Co-operative Housing Society Ltd., No. P.795 is expiring on 31.03.2026.

AND WHEREAS, the Committee of management of the said society requested the Registrar of Co-operative Societies to extend its term of office for a further period of one year i.e., from 01.04.2026, stating that all their members are government employees and at present they are engaged in the election duty in the General Election to the Legislative Assembly of Puducherry and unable to conduct election to the committee of management before 31.03.2026 i.e., the expiry of the term of existing Committee of management;

AND WHEREAS, in view of the reasons put forth by the committee of management of the said society, I am satisfied that the term of office of the existing committee of the said society is to be extended,

NOW THEREFORE, in exercise of the powers conferred on me under clause (b) of sub-section (5) of the Section 32 of the Puducherry Co-operative Societies Act, 1972 read with sub rule (2) of Rule 41 of the Puducherry Co-operative Societies Rules, 1973, I extend the term of office of the existing committee of management of the Puducherry State Government Driver's Co-operative Housing Society Ltd., No. P.795 for a period of three months i.e., from 01.04.2026 to 30.06.2026.

The said committee is strictly directed to arrange to conduct and complete the election to the Committee of Management of the said society on or before 30.06.2026 in order to constitute new committee of management within the extended period.
