4	Limit of loan: The maximum amount of loan that may be sanctioned to a member under these regulations shall not exceed Rs.20,000/- (Rupees twenty thousand only) : Provided that, no member shall be indebted to the society to the maximum loan amount as fixed under clause 4 of the Subsidiary Regulations governing the sanction of medium – term loan to members of the society at any time.	Limit of loan: The maximum amount of loan that may be sanctioned to a member under these regulations shall not exceed Rs. 30,000/- (Rupees thirty thousand only) : Provided that, no member shall be indebted to the society to the maximum loan amount as fixed under clause 4 of the Subsidiary Regulations governing the sanction of medium – term loan to members of the society at any time.
