PROCEEDINGS OF THE REGISTRAR OF COOPERATIVE SOCIETIES, PUDUCHERRY
(Issued under Section 33 of the Puducherry Coop. Societies Act, 1972)

Sub: The Pondicherry Cooperative Milk Producers' Union Employees Cooperative Credit Society Ltd., No.P.374-- Resignation of seven (7) Directors from the committee of management – Defunct of committee - **Appointment of an Administrator** under Section 33 of the Puducherry Cooperative Societies Act, 1972 – Order – Issued.

Read: (1) Resignation letters dated **29.8.2023** received from the seven Directors of the committee of management of the **Pondicherry Cooperative Milk Producers' Union Employees Cooperative Credit Society Ltd., No.P.374**

(2) Inspection Report under section 76 of the PCS Act, 1972 dated 31.8.2023 submitted by Tmt. K. Danalakshmi, Senior Inspector, Planning Section.

(3) Representation dated 25.8.2023 received from the members of the society through office of the Secretary (Cooperation).

ORDER:

WHEREAS, an election was held on 10.12.2021 to elect nine (9) Directors to the committee of management (**for short "the committee"**) of the **Pondicherry Cooperative Milk Producers' Union Employees Cooperative Credit Society Ltd., No.P.374 (for brevity "the society")**, by and from among the members of the society, to hold office from **18.12.2021 to 31.03.2024**;

2) AND WHEREAS, in the said election, the following nine (9) members of the society were elected as Directors of the society ;

3) AND WHEREAS, out of the above said nine Directors, the following seven (7) Directors, who consists of the Vice-President, the Treasurer and five (5) Directors, have tendered their resignation dated **29.8.2023** to the President of the society and forwarded a copy thereof to the undersigned;

4) AND WHEREAS, as per the bye-laws of the society, the committee consists of nine (9) members and the quorum required for convening meeting of the committee is **five (5)**. Out of nine (9) elected Directors, seven (7) of them have tendered their resignation from the committee, by which, the strength of the committee is reduced to **2** which is not sufficient to convene the meeting of the committee;

5) AND WHEREAS, in view of the above, it is evident that, due to the said resignations, there is no quorum for the committee;

6) AND WHEREAS, in the inspection report dated 31.8.2023, it is reported that five directors were dissatisfied with the functioning of the President;

7) AND WHEREAS, the members in their representation cited under reference requested the Registrar of Cooperative Societies to take immediate action for the functioning of the society as the directors tendered their resignation and it will not be possible to operate the society;

8) AND WHEREAS, on the above premises, the undersigned has proposed to appoint an Administrator, under Section 33 of the Puducherry Cooperative Societies Act, 1972 (**for brevity "the Act"**), to manage the affairs of the society;

9) AND WHEREAS, sub-section (1)(b) of Section 33 of the Act provides that, before making an order, the financing bank, viz., the Puducherry State Cooperative Bank Ltd., is to be consulted. Hence, the said financing bank was consulted. The said financing bank consented for the appointment of an Administrator to the society;

10) AND WHEREAS, first proviso to sub-section (1) of Section 33 of the Act provides that, before making an order, a notice shall be published on the notice board of the society inviting objections. The second proviso to sub-section (1) of Section 33 of the Act provides that, it shall not be necessary to publish such notice in case where the Registrar is satisfied that it is not reasonably practicable to do so. As an alternative arrangement has to be made expeditiously and due to lack of sufficient time to publish a notice, the undersigned has decided to dispense with the publication of the said notice;

11) AND WHEREAS, in view of the above facts, the undersigned is satisfied that, there is no other alternative, except that, the said elected committee is to be replaced by an Administrator, to be appointed under Section 33 of the Act;



12) **NOW, THEREFORE**, in view of the above facts and as an alternative interim arrangement till a new committee is installed through election and in exercise of the powers conferred on the undersigned under Section 33 of the Puducherry Cooperative Societies Act, 1972, **the undersigned hereby appoints Thiru. R. Vengadesan, Senior Inspector, Planning Section of this Department as the Administrator of The Pondicherry Cooperative Milk Producers' Union Employees Cooperative Credit Society Ltd., No.P.374 , in addition to his normal official duties, with immediate effect vice the existing elected committee of management. Charges handed over to the said Administrator is to be intimated to this office.**

13) The said Administrator shall have powers to exercise all or any of the functions of the committee or any other officer of the society and take all such actions as may be required in the interest of the society. The administrator is instructed to conduct election to the Committee of Management to install a new committee of Management at the earliest.
