ORDER:

WHEREAS, the term of office of the existing committee of management of the Mahe Labour Contract Co-operative Society Ltd., No. P. 724 expired on 31.3.2026.

2. **AND WHEREAS**, the said committee of management has requested the Registrar of Co-operative Societies to extend its term of office for a period of three months from 01.04.2026 to 30.06.2026, stating that the election to the committee of management of the society could not be conducted before expiry of its term, due to declaration of the Puducherry Legislative Assembly Election and enforcement of the Model Code of Conduct.

3. **AND WHEREAS**, in view of the reasons put forth by the committee of management of the said society, the Registrar is satisfied that the term of office of the existing committee of the said society is to be extended;

4. **NOW THEREFORE**, in exercise of the powers conferred under clause (b) of sub-section (5) of Section 32 of the Puducherry Co-operative Societies Act, 1972 read with sub rule (2) of Rule 41 of the Puducherry Co-operative Societies Rules, 1973, the Registrar of Co-operative Societies hereby extends the term of office of the existing committee of management of the Mahe Labour Contract Co-operative Society Ltd., No. P. 724 for a period of three months, i.e., from 01.04.2026 to 30.06.2026;

5. The said committee is strictly directed to take necessary action to conduct and complete the election to the committee of management before expiry of the extended period i.e. **30.06.2026** and to constitute a new committee within the extended period, without fail.
