3. Representation dt:06.07.2023 received from members of the Mother Theresa Anganwadi Employees Co-operative Credit Society Ltd., No. P.804 and Inspection Report dt: 10.08.2023 received from Thiru.A.Irusappan, Senior Inspector, Co-operative Department.

WHEREAS the term of the Committee of Management of Mother Theresa Anganwadi Employees Co-operative Credit Society Ltd., No. P.804 expired on 31.03.2023

2. AND WHEREAS, on request of the existing Committee of Management, the term of the existing committee was extended up to 30.6.2023 vide proceeding in reference 1st cited and further extended up to 30.9.2023 vide proceeding reference 2nd cited with instructions to complete the election before the extended period;

3. AND WHEREAS, it is reported in the inspection report cited in reference 3rd that, the existing Committee of Management has not properly conducted General Body Meeting for division of constituency and failed to take proper steps to conduct election to the new Committee of Management before the extended period of the existing Committee of Management;

4. AND WHEREAS, the Registrar is of the opinion that a new committee cannot be constituted before the expiry of the extended term of office of the existing committee;

5. AND WHEREAS, in the circumstances stated above, the Registrar of Co-op. Societies has proposed to appoint an Administrator under sub-section (1) of the section 33 of the Puducherry Co-op. Societies Act, 1972 to manage the affairs of the said society;

6. AND WHEREAS, the financing bank viz. Pondicherry State Co-operative Bank has been consulted in this regard and the said bank has no objection for appointing an Administrator to the said society;

7. AND WHEREAS, the Registrar of Co-operative Societies is also satisfied that it is not practicable to publish a notice inviting objections to the proposal for appointment of an Administrator to the said society as required under the first proviso to sub-section (1) of the section 33 as alternative arrangements is to be made expeditiously;

8. NOW THEREFORE, in view of the above and in exercise of the powers conferred on me under sub-section (1) of the section 33 of the Pondicherry Co-operative Societies Act, 1972 the Registrar of Co-operative Societies hereby appoints **Thiru. K.Balamurugan, Welfare Officer, Department of Women and Child Development, Puducherry as the Administrator of the Mother Theresa Anganwadi Employees Co-operative Credit Society Ltd., No. P.804 with effect from 01.10.2023.**

9. The Administrator shall exercise all the functions of the said committee subject to my control and such directions as I may give from time to time under sub-section (2) of the said section and take all such action as may be required in the interest of the said society.
