It is ascertained that, in short duration the committee has violated the instructions laid down in the proceedings 1st cited above.

AND WHEREAS, an explanation has been called for from the President of the Three Member Committee vide this office letter 2nd cited above;

AND WHEREAS, the President of the Three Member Committee has given a very vague explanation;

AND WHEREAS in view of the above reason, I have decided, on my own motion, to appoint an Administrator, to manage the affairs of the said society till a new committee enters upon office;

AND WHEREAS, the undersigned is also satisfied that it is not reasonably practicable to publish a notice, inviting objections to the said proposal, as required under the provisions of sub section (1) of section 33 of the Puducherry Cooperative Societies Act, 1972, as an alternative arrangement is to be made expeditiously to manage the affairs of the said society;

NOW, THEREFORE, in view of the above and in exercise of the powers conferred on me under sub section (1) of section 33 of the Puducherry Cooperative Societies Act, 1972, I hereby appoint **Thiru. K. Dhanabalan, Co-operative Officer / Liquidator as Administrator of the Sooramangalam Co-operative Milk Producers' Society Ltd., No.P.291** with immediate effect in addition to his normal duties with an instruction to arrange to conduct election and form a elected committee of management within two months.

The Administrator, shall exercise all the functions of the committee, subject to my control and to such instructions as I may, from time to time give, have powers to exercise all or any of the functions of the committee or any officer of the society and take all such action as may be required in the interest of the society under sub section (2) of the section 33 of the said Act.
