In pursuance to the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Co-operative Societies, Puducherry hereby permits **the Puducherry Vector Control Research Centre Staff Cooperative Thrift & Credit Society Ltd., No.P.402** to incur an expenditure not exceeding **Rs.2,91,844/- (Rupees two lakhs ninety one thousand eight hundred and forty four only)**, from the general funds of the said society, towards disbursement of interest rebate to **60 members** of the said society for the year **2023-24 through Electronic Clearing Service (ECS)**, as **ten percent (10%) rebate** for the interest collected of **Rs.29,18,402/-** during the year **2023-24**.
