**ORDER:**

In pursuance of the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Co-operative Societies hereby permits Pondicherry Co-operative Urban Bank Staff Coop. Credit Society Ltd., No.P.698 to incur an expenditure of not exceeding **Rs.30,200/-** (Rupees thirty thousand and two hundred only), from the general funds of the said society, towards disbursement of interest rebate to **56** members of the said society for the year 2024-25, **through Electronic Clearing Service (ECS)**, as **two percent ( 2 %) rebate** for the interest collected of **Rs.17,75,265/-** subject to a maximum ceiling of Rs. 1000/- per member for the year 2024-2025.

The actual expenditure shall be charged in the accounting year 2024-25 itself and proper account shall be maintained for the disbursement of interest rebate.
