ORDER:

In pursuance of the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Cooperative Societies hereby permits the **Pondicherry Co-operative Urban Bank Staff Coop. Credit Society Ltd., No.P.698** to utilize a sum of not exceeding **Rs.38,000/-** (Rupees thirty eight thousand only), from out of the general funds of the said society, towards the issue of gift coupons to 76 members of the said society, worth **Rs.500/-** (Rupees five hundred only) each, which enables them to make purchases only from the below mentioned cooperative institutions, in commemoration with the International Year of Co-operatives - 2025 (IYC-2025) and in alignment with the Co-operative principle of Cooperation among Co-operatives.

Institutions:

- i. The Pondicherry Co-operative Milk Producers' Union Ltd., No. P.1 (PONLAIT)
- ii. Pondicherry State Co-operative Consumers Federation No. P. 429 (CONFED)

The actual expenditure shall be charged in the accounting year 2024-25 itself and proper account shall be maintained for the issue of gift coupons.
