ORDER:

WHEREAS, the extended term of office of the Committee of Management of the Pondicherry Co-op. Handloom Export Development Project Ltd. No. P-433 expires on 30th September, 2024;

AND WHEREAS, a new committee was not being constituted before the expiry to the term of office of the existing committee of the said society due to administrative reasons;

AND WHEREAS, in view of the above, I am of the opinion that an Administrator is to be appointed under Section 33 of the Puducherry Co-operative Societies Act, 1972 to manage the affairs of the said society till a new committee enters upon the office;

AND WHEREAS, I am satisfied that it is not reasonably practicable to publish a notice, inviting objection to the above said proposal, as required under the first proviso to sub-section (1) of the said section, as alternative arrangements are to be made expeditiously;

NOW THEREFORE, in exercise of the powers conferred on me under sub-section (1) of Section 33 of the Puducherry Co-operative Societies Act, 1972, I hereby appoint **Thiru. V. Vencata Srinivassachariolou, Deputy Registrar (Planning), Co-operative Department, Puducherry** as the Administrator of the Pondicherry Co-operative Handloom Export Development Project Ltd. No. P-433 with effect from 01.10.2024, in addition to his normal duties, till a new committee enters upon the office.

The Administrator shall exercise all the functions of the Committee, subject to my control and to such instructions, as I may give, from time to time, under sub-section (2) of the said section.

The Administrator shall arrange to conduct election early and to form a new Committee of Management as per sub-section (3) of said Section, after sorting out the present issues.
