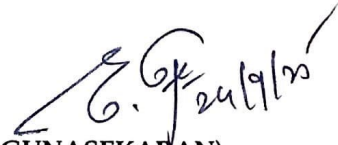

ORDER:

In pursuance of the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Co-operative Societies permits the Karaikal Multi-Tasking Staff Co-operative Credit Society Ltd., No.P.425 to utilize an amount of Rs.7,41,975/- (Rupees seven lakh forty one thousand nine hundred and seventy five only) from the general funds of the society towards disbursement of interest rebate to 269 members of the said society for the year 2024-2025, as detailed below, through Electronic Clearing Service (ECS). The actual expenditure shall be charged in the accounting year 2024-2025 itself and proper account shall be maintained for the disbursement of interest rebate.
