ORDER:

In pursuance of the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Co-operative Societies Rules, 1973, the Registrar of Co-operative Society hereby permits the Puducherry Judicial Staff Cooperative Credit Society Ltd., No.P.502, to incur an expenditure restricted to **Rs.3,52,500/- (Rupees three lakhs fifty two thousand five hundred only)** against **Rs.3,75,000/- requested**, from the general funds of the society, towards issue of **gift coupons to 141 members** of the society, worth **Rs.2,500/- (Rupees two thousand five hundred only)** each, which enables them to make purchase only from the following cooperative institutions in commemoration of the International Year of Co-operatives 2025 (IYC 2025) and in alignment with the Co-operative principle of "Co-operation among Co-operatives"
