ORDER:

In pursuance of the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Cooperative Societies hereby permits the **Pondicherry Engineering College Staff Coop. Credit Society Ltd., No.P.647** to utilize a sum not exceeding of **Rs.9,31,000/-** (Rupees nine lakh thirty one thousand only) from out of the general funds of the said society, towards the issue of gift coupons to **266** members of the said society, worth **Rs.3500/-** (Rupees three thousand five hundred only) each, which enables them to make purchases only from the below mentioned cooperative institutions, in commemoration with the International Year of Co-operatives – 2025 (IYC-2025) and in alignment with the Co-operative principle of Cooperation among Co-operatives.
