ORDER:

In pursuance to the reference cited and in exercise of the powers conferred on me under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, I permit the **Puducherry Govt. Group B & C Staff Coop. Credit Society Ltd., No.P.691** to incur an expenditure of not exceeding **Rs.7,23,000/-** (Rupees seven lakhs twenty three thousand only), from the general funds of the society, towards issue of **gift coupons to 723 members** of the society, worth **Rs.1,000/-** (Rupees one thousand only) each, which enables them to make purchase only from the following cooperative institutions:
