ORDER:

In pursuance of the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Co-operative Societies permits the PWD Staff Co-operative Credit Society Ltd., No.P.445 to utilize an amount of **Rs.9,92,578/-** (Rupees Nine lakh ninety two thousand five hundred and seventy eight only) from the general funds of the society towards disbursement of **interest rebate to 186 members of the said society for the year 2024-2025**, as detailed below, **through Electronic Clearing Service (ECS)**. The actual expenditure shall be charged in the accounting year 2024-2025 itself and proper account shall be maintained for the disbursement of interest rebate.
