Read: Letter dated 25-09-2025 received from the Treasurer of the Jipmer Staff Cooperative Thrift and Credit Society Ltd., No.P.231, along with a true copy of Resolution No. 6 of the Committee Meeting held on 16-09-2025.

ORDER:

In pursuance of the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Co-operative Societies Rules, 1973, the Registrar of Co-operative Societies, Puducherry, hereby permits the Jipmer Staff Cooperative Thrift & Credit Society Ltd., No.P.231 to incur an expenditure not exceeding Rs. 26,53,000/- (Rupees twenty-six lakh fifty-three thousand only), from the general funds of the society for the issue of gift coupons, each worth Rs. 1,000/- (Rupees One thousand only) to 2653 members of the society in commemoration of the International Year of Co-operatives - 2025 (IYC 2025), and in alignment with the cooperative principle of "Co-operation among Co-operatives."

The gift coupons shall be redeemable only at the following co-operative institutions:

1. Pondicherry Cooperative Wholesale Stores Ltd., No.P.44 (Amudhasurabi)
2. Puducherry State Weavers Cooperative Society Ltd., No.P.57 (PONTEX)
3. Pondicherry Co-op. Handloom Export Development Project Ltd., No.P.760 (PONFAB)
4. Pondicherry Cooperative Building Centre Ltd., No.P.554
5. Pondicherry Central Co-op. Processing, Supply & Marketing Society Ltd., No.P.31.
6. Pondicherry Cooperative Milk Producers' Union No. P. 1 (PONLAIT)
7. Pondicherry State Co-operative consumers Federation No. P.429 (CONFED)

The actual expenditure shall be charged in the accounting year 2025-2026 itself and proper records shall be maintained for the issuance and redemption of gift coupons.
