ORDER:

In pursuance of the references cited and in exercise of the powers vested under Rule 58 of the Puducherry Co-operative Societies Rules, 1973, the Registrar of Co-operative Societies, Puducherry, hereby **accords permission** to the Puducherry Health Employees Co-operative Credit Society Ltd., No. P.475, to incur an expenditure not exceeding Rs.45,11,000/- (Rupees Forty-five lakh eleven thousand only) from the **general funds** of the society.

The said expenditure is approved towards the distribution of gift coupons to the members and associate members of the society, as per the details furnished below, to facilitate purchases exclusively from the Pondicherry Central Co-operative Processing, Supply & Marketing Society Ltd., No. P.31. This initiative is undertaken as part of the commemoration of the International Year of Cooperatives – 2025 (IYC 2025) and is in alignment with the co-operative principle of “Co-operation among Co-operatives.”
