In pursuance to the reference cited and in exercise of the powers conferred on me under **Rule 15** of the subsidiary regulations governing the sanction of **short-term loan** to members of **Puducherry Government Teachers' Cooperative Credit Society Ltd., No.P.676**, I approve the amendment made to **Rule No.4** of the said regulations, vide resolution cited and as detailed hereunder. The said amendment shall come into force from the date of issue of this proceedings.

Subsidiary regulation governing the sanction of short-term loan to members		
Rule No.	As Existing	As Amended
4	Limit of loan: The maximum amount of loan that may be sanctioned to a member under these regulations shall not exceed Rs.2,00,000/- (Rupees two lakhs only). Provided that, no member shall be indebted to the society for a sum exceeding Rs.20,00,000/- (Rupees twenty lakhs only) at any time.	Limit of loan: The maximum amount of loan that may be sanctioned to a member under these regulations shall not exceed Rs.2,00,000/- (Rupees two lakhs only). Provided that, no member shall be indebted to the society for a sum exceeding Rs.25,00,000/- (Rupees twenty five lakhs only) at any time.
