ORDER:

In pursuance to the reference cited and in exercise of the powers conferred on me under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, I permit Mahatma Gandhi Postgraduate Institute of Dental Science Staff Co-operative Credit Society Ltd., No.P.717 to incur an expenditure of not exceeding Rs.9,78,777/-(Rupees Nine lakhs seventy eight thousand seven hundred and seventy seven only), from the general funds of the said society, towards disbursement of interest rebate to 131 members of the said society for the year 2022-23, as 10% rebate for the interest collected of Rs.97,87,773/- during the year 2022-23, through Electronic Clearing Service (ECS).
