ORDER:

In pursuance to the reference cited and in exercise of the powers conferred on me under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, I permit the JIPMER Staff Cooperative Thrift & Credit Society Ltd., No.P.231 to incur an expenditure of not exceeding **Rs.1,03,30,149.51/-** (Rupees one crore three lakhs thirty thousand one hundred forty nine and fifty one paise only), from the general funds of the said society, towards the disbursement of interest rebate to **1825 members** of the said society for the year 2021-22, as **nine percent (9%) rebate** for the loan interest collected of **Rs.11,47,79,439/-** during the year 2021-22, through Electronic Clearing Service (ECS). The actual expenditure shall be charged in the accounting year 2021-22, itself and proper account shall be maintained for the disbursement of interest rebate.
