PROCEEDINGS OF THE REGISTRAR OF COOPERATIVE SOCIETIES, PUDUCHERRY

(Issued under Section 33 of the Puducherry Cooperative Societies Act, 1972)

Sub: Amutham Cooperative Credit Society Ltd., No.P.638 – Elected committee of management
- Resignation of six (6) Directors from the committee of management – Defunct of committee - Appointment of an Administrator under Section 33 of the Puducherry Cooperative Societies Act, 1972 – Order – Issued.

Read: (1) Resignation letters received from the six directors of the committee of management of Amutham Cooperative Credit Society Ltd., No.P.638.

(2) Letter dated 11.01.2022 received from the President of Amutham Cooperative Credit Society Ltd., No.P.638

ORDER:

WHEREAS, an election was held on 22.09.2019 to elect nine (9) Directors to the committee of management (for short “the committee”) of the Amutham Cooperative Credit Society Ltd., No.P.638 (for brevity “the society”), by and from among the members of the society, to hold office from 01.10.2019 to 31.03.2022;

2) AND WHEREAS, in the said election, the following nine (9) members of the society were elected as Directors of the society:

3) AND WHEREAS, out of the above said 9 directors, the Vice-President along with 5 directors have tendered their resignation dated 11.01.2022 to the Registrar of Co-operative Societies (for brevity “RCS”), and forwarded a copy thereof to the President of the society;

4) **AND WHEREAS**, as per the bye-laws of the society, the committee is empowered to accept the resignation tendered by the members of the committee. The President in his letter dated 11.01.2022 requested RCS to appoint a Special Officer for the society as it is difficult to manage the affairs of the society as the six directors of the society tendered their resignation on 11.01.2022;

5) **AND WHEREAS**, as per the bye-laws of the society, the quorum required for convening a meeting of the committee is five (5). Out of the 9 elected directors, 6 of them have tendered their resignation from the committee, by which, the strength of the committee has reduced to 3, which is not sufficient to convene a meeting of the committee;

7) **AND WHEREAS**, in view of the above, it is evident that, there is no required quorum of 5 directors to conduct business and the committee has become defunct;

8) **AND WHEREAS**, on the above premises, the undersigned has proposed to appoint an Administrator, under Section 33 of the Puducherry Cooperative Societies Act, 1972 (*for brevity "the Act"*), to manage the affairs of the society;

9) **AND WHEREAS**, sub-section (1)(b) of Section 33 of the Act specifies that, before making an order, the financing bank, viz., the Puducherry State Cooperative Bank Ltd., is to be consulted. The financing bank was also consulted. The said financing bank consented for the appointment of an Administrator to the society;

10) **AND WHEREAS**, first proviso to sub-section (1) of Section 33 of the Act specifies that, before making an order, a notice shall be published on the noticeboard of the society inviting objections. The second proviso to sub-section (1) of Section 33 of the Act specifies that, it shall not be necessary to publish such notice in case where the Registrar is satisfied that it is not reasonably practicable to do so. As an alternative arrangement has to be made expeditiously and due to lack of sufficient time to publish a notice, the undersigned has decided to dispense with the publication of the said notice;

11) **AND WHEREAS**, in view of the above, the undersigned is satisfied that, the committee is to be replaced by an Administrator to be appointed under Section 33 of the said Act;

12) **NOW, THEREFORE**, in view of the above and in exercise of the powers conferred on the undersigned under sub-section (1) of Section 33 of the Puducherry Cooperative Societies Act, 1972, the undersigned hereby appoint **Thiru. K. Maran, Senior Inspector, Credit Section, Cooperative Department** as the Administrator of Amutham Cooperative Credit Society Ltd., No.P.638, in addition to his normal official duties, with immediate effect. Charges handed over and taken over are to be intimated to this office.



13) The said Administrator shall, subject to the control of the undersigned and to such instructions as the undersigned may, from time to time, give, have powers to exercise all or any of the functions of the committee or any other officer of the society and take all such actions as may be required in the interest of the society.

14) *The said Administrator is directed to arrange for conduct of election at the earliest.*
